## **Review and approve minutes from previous meeting (4-4-23)**

**Motion to approve the minutes from the April 4, 2023 meeting as distributed via email (DeCunzo). Second (Wright). Passed unanimous.**

## **Old Business** (Issues previously discussed which require follow-up)

- Common Mapping System
  - Jon Trapp provided an update from the conference he attended  
*Conference was hands-on, skill- based learning. Reviewed Land SAR Software which has been updated to a regional format and utilizes a different functionality for search operations and search management to ensure an entire area is being covered. Also reviewed CALTOPO and SARTOPO and some of the functionality that the company is incorporating into SARTOPO, such as a live feed via drone option. SARTOPO seems to be the most prevalent mapping system at this point. Landstar is available and government owned which means people have access.*
  - OnX statewide coordination options (Jurgonski)  
*Jurgonski spoke with one of the owners of OnX, and they are currently working on additional SAR features (similar to SARTOPO with live tracking), but likely about a year out from full implementation.*
  - Chair Secor reminded people that the subcommittee is gathering information on available mapping software solutions with the goal of presenting the viable options to teams. The subcommittee has no authority to require any team to use a specific mapping software; however, goal is to explore the possibility of a common mapping system that could be used statewide, which will ultimately help during mutual aid assistance between teams and agencies.
- Online Reimbursement Form – Must use starting 7-1-23  
*Starting July 1, 2023, all reimbursement requests must be submitted via the online system (<https://mtsar.org/reimbursement/>). The PDF reimbursement forms will not be accepted. The online form is intuitive and easy to use and will ensure that there is a cloud-based record of all reimbursement requests submitted. This should eliminate reimbursements being inadvertently overlooked in someone's email inbox.*
- Unique Local Number  
*Reminder that the unique local number is specific to your agency/county and the purpose is to track expenses/debts and income/credits for your finance officer. Not all agencies/counties have a system in place requiring the use of a unique identifier for all credits/debts. The submitter determines the number in order to track the money per the requirements in your county. A number must be entered, so enter any number (such as 1111) if your county does not require a tracking number.*

**New Business** (Emerging issues which require attention from the SAR Subcommittee)

➤ Chair Secor Retirement

*Chair Secor is retiring in September. There will be a new SAR Subcommittee Chair. The Chair is selected by the MSPOA President. A new person will be in place and present at the next meeting. As soon as the new Chair is named, an email will be sent to ensure all subcommittee members have a direct point of contact for SAR related issues. You should not notice much difference or impact beyond a new point of contact.*

*On behalf of the subcommittee, Gilbertson thanked Scott for his work as Chair. Scott dedicated a significant amount of time, energy, and expertise to the SAR subcommittee.*

➤ Reimbursement Amount Adjustments

*On July 1, 2023, the maximum reimbursement amount changes from \$50,000 to \$12,000.*

*The maximum of \$12,000 is per submission for mission, training, and equipment reimbursement requests. The Chair will continue to try to ensure teams get the full amount of reimbursement possible.*

➤ Reevaluate reimbursement process

*For the first time there is a larger amount of reimbursement requests than there is cash and authority for reimbursements.*

*Secor suggested reevaluating how reimbursements are approved and specifically the timeline by which reimbursements are reviewed and voted with the goal of ensuring a fair and equitable distribution of funds. Asked the subcommittee to consider holding all reimbursement requests until the end of the year to ensure money is disbursed on a fair and equitable basis.*

*Chair Secor also reminded the subcommittee that all reimbursement requests are reviewed prior to being placed on the agenda to confirm the reimbursement is SAR appropriate, meets the requirements as prescribed in the operating procedures, have the proper documentation, and all of the numbers add up. Beyond that, it is not really the responsibility of the Chair and subcommittee to make a subjective value judgement on the reimbursement request.*

*Super: Since 50% of the appropriation must be utilized for mission reimbursements, those could continue to be reviewed on a quarterly basis and then training and equipment reimbursements could be held until the end of the year.*

*There are different resources available in the different counties/areas of the state, which makes costs and reimbursements vastly different.*

*Trapp: As far as reimbursements are concerned, the following should be considered: dedicated SAR mill levy; however, those are not equitable across various counties, if the SAR Team utilized the lowest cost option(s) first, priority of mission, training, equipment. We do not want*

*reimbursement or lack of reimbursement to negatively impact the citizens we serve.*

*O'Donnell: SAR Teams need to keep each other apprised of available resources. National Guard in Billings will likely have a SAR helicopter up and running in the next year. Also asked if there are statutory prohibitions for SAR Teams billing people for the service rendered.*

*DeCunzo: Data suggests that a fee for SAR services is not the best and safest option.*

*Secor: Concur that we do not want the state of Montana to go down the road of a fee for service model because in the long run it can result in worse outcomes for the recipient of the SAR service and more dangerous conditions for the SAR team members to conduct missions.*

*Bradley: Worth looking at the ability a team has to pay and using that as part of a weighted calculation to help determine how to disburse available funds. The subcommittee could create a weighted calculation for the counties based on their ability to pay.*

*Jurgonski: You would then also have to add in call volume as another factor for a weighted calculation.*

*Secor: In an effort to be fair and equitable across the state, a weighted system will not likely result in the best distribution of funds because there are so many factors and variables for counties, agencies, and teams across the state.*

*Curtis: It would be very hard to put teams on a scale and measure them against each other. Want to have clear criteria for reimbursements but caution against a value-based system.*

*Super: For a long time it was a struggle to get counties to ask for reimbursement, especially those who do have a mill levy, so it is good that teams are actually asking this year. Sliding scale/partial reimbursement is likely the best option. Waiting until the end of the year might be a hardship for some counties.*

*DeCunzo: There is the expertise within the committee to evaluate the training reimbursement requests and evaluate their merit. Prior to the availability of state funding, mission, training, and equipment were all funded at the local level. There is no guarantee on the state funds.*

*Jurgonski: Recommend evaluating and approving mission reimbursements on a biannual basis with a conservative approach in order to hold back funds for mission reimbursement for the end of the year. Reimburse on a partial basis and if there is money left at the end of the year partial reimbursements could be made whole or have an additional reimbursement.*

*Belke: Chair Secor has given a lot of thought to this and support his recommendation to evaluate the reimbursement process and appreciate Gallatin County pulling their requests.*

*Steele: Could the reimbursement form include some sort of a matrix or list of local resources that have been exhausted prior to asking for state resources?*

*Secor: The question at hand is how often we want to evaluate and vote on reimbursement requests for missions, trainings, and equipment. Do we want to do reimbursements once per year for all three in an effort to make sure the money is distributed in a fair and equitable manner?*

*Burke: Has there been discussion about assigning a set budget for reimbursements on a per county basis?*

*Jurgonski: Make a proposal to approve missions quarterly and trainings and equipment on an annual basis.*

*Gainieany: Asked if holding both training and equipment reimbursements to the end of the year would cause issues on the financial side.*

*Gilbertson: All reimbursements could be submitted throughout the year and DES could have a running balance of how much money has been requested throughout the year to make sure both the authority and cash are available when it comes time to approve reimbursement requests and/or equitably allocate the funds.*

*Motion to accept mission, training, and equipment reimbursement requests throughout the year, but review and approve/deny reimbursement requests at the final meeting of the state fiscal year (Curtis). Second (Jurgonski).*

*DeCunzo: Do not support the motion. Funds for missions should be disbursed throughout the year and the priority should be on missions. Should offer a caveat at the beginning of the year that the funds are on a reimbursement basis and there is no guarantee of mission, training, or equipment reimbursement.*

*Amendment to the Motion: Review, vote on, and reimburse mission reimbursement requests on a quarterly basis. Accept training and equipment reimbursement requests throughout the year, but review and approve/deny training and equipment reimbursement requests at the final meeting of the state fiscal year (Curtis). Second of the Amendment to the Motion (Jurgonski). Passed unanimous.*

*Wright: Functionally, the only change from status quo is holding training reimbursement requests until the end of the year as is currently done with equipment requests.*

*Welch: Request the subcommittee finalize reimbursement requests 30 days prior to the end of the state fiscal year which will help teams with their budget planning.*

*Secor: The subcommittee can decide when the final meeting of the state fiscal year takes place and have a process in place to review and vote on reimbursement requests which are submitted after the final meeting.*

    - March 28, 2023
    - Total = \$ 5,025.00
    - Approved = \$5,025.00**
    - Reimbursement Purpose = Helicopter flight time
    - Resources: 26 SAR Volunteers 1 SAR Deputy Central Copters 14x*
    - Narrative: The patient was involved in a snowmobile accident on Green Mt. Pt stated that he had a broken leg and was unable to move. He was alone but dressed for conditions. He was 6 miles up in technically challenging steep terrain. His track was the only one up there, and his vehicle was parked at the bottom by the locked gate. GCSO Deputy #655 was able to talk with the patient via cell phone numerous times to monitor his condition as SAR teams were mobilized and a rescue plan was initiated. Weather conditions were deteriorating with blowing snow and temps. in the 20's as teams mobilized. Air ambulance would not respond. Due to the terrain, injury, and weather conditions ground teams and heli team were deployed, Snowmobile Team 1 and helicopter 14X reached the patient at 1745 and were able to load him into the helicopter near the incident scene. He was flown down to Jackson Creek Road to a LZ near the Staging area where he was transferred into the care of AMR1.*
    - Resolution: Patient was flown from accident scene via helicopter to an awaiting ambulance.*
    - Motion to approve the Gallatin County SAR Mission SAR Reimbursement for \$5,025.00 with funding authorized by State DES utilizing the appropriate fund source (Jurgonski). Second (DeCunzo). Approved unanimous.***

Reimbursement Purpose = Mileage

*Resources: 29 members responded to the mission call out. All 29 members deployed. 20 members drove personal vehicles. 2 SAR vehicles responded. 1 member brought UTV. 14 snowmobiles were brought by members responding.*

*Narrative: On 4/8/23 at 1757 hours the 15-90 SAR Commander received an alert that a snowmobiler (In Reach contact thru Sheriffs dispatch) had gone off a 100 ft cliff and had a broken back and other serious injuries. Members were notified and responded. Lat/Long was received which modified search location. Three access points, none convenient, snow conditions bad. Plan was to access site from 2 directions and extricate by sled if necessary. In route IC identified an LZ and requested Lifeflight (also a lifeflight pilot riding with victim). Lifeflight responded. 15-90 hasty team arrived on scene 1925 hours and unloaded equipment, second team with recovery equipment, board, rescue sled sent to second location at 1930 hours. Notified Lifeflight on ground at 1935 hours. Suspended operations until Lifeflight indicates recovery has occurred. Load up return to base, sign out at 2215.*

*Resolution: Victim extricated by Lifeflight, now in SLC, broken back, shoulder, sternum, etc.*

Reimbursement Purpose = Mileage, Vehicle Repair

*Resources: 8 members were called out to retrieve 6 skiers on Red Mountain. Dispatched the Trucker SnoCat, a tracked side by side, and 3 tracked ATVs to locate and bring them out.*

*Narrative: 8 members responded to Red Mountain to recover 6 skiers/1 dog. It was 70 degrees and snow was 10 ft deep, conditions terrible. All skiers recovered in good condition and returned to Butte. The Polaris side by side went into deep snow in open meadow and the sno-pack collapsed, depth of snow for approx. 1 acre dropped 2 feet in a second. It was not an avalanche area. The sxs buried itself down to grass with snow depth over cab of vehicle. Trenched to ramp up out of drift but the differential broke and the front tracks wouldn't turn. At that point brought Tucker snocat to pull it out. More trenching. Put front tracks of sxs in game sleds and pulled it back to town. Total time out approx. 6 hours.*

*Resolution: Six backcountry skiers and a dog were safely extricated from the backcountry.*

*Resources: Comms Team-2 Valley Section-9 Heli Team-4 SAR Deputy-2*

*Narrative: On May 30, 2023, at 3:57 pm, Gallatin County Dispatch received a phone call from a stranded hiker at the Ross Pass Junction. The hiker started their expedition at Fairy Lake and planned on traversing the Bridger Ridge. The hiker encountered deep snow, was not equipped for the conditions, and was becoming hypothermic. The hiker had a charged cell phone and was able to send rescuers an exact location. Gallatin County Sheriff Search and Rescue (GCSSAR) members responded to the scene utilizing four wheelers and utility vehicles. The GCSSAR Heli Team was also deployed due to patent condition and terrain. The helicopter dropped off rescuers who were able to walk the patient to meet the ground team. Volunteers were able to successfully transport the hiker down the trail. Reimbursement request is for flight time only.*

*Narrative: On June 11th, 2023, a deceased male was found floating in the Missouri River several miles downstream from James Kipp Campground. Montana FWP Wardens and Fergus County Sheriff's Deputies responded to recover the body. Central Montana Search and Rescue responded with a Hasty team, and they worked with LE on scene to locate a camp, capsized boat or possibly other victims. On the morning of June 12th, an airplane from Skyline Aviation assisted with locating the deceased male's camp or boat and to look for other victims. Several jetboats searched as well. On June 15th, 2023, the deceased male's camp and fishing gear were located near the confluence of Bull Creek and the Missouri River. No other victims were located. Reimbursement request is for flight time only.*

***Reviewed all Mission reimbursement requests as provided on the agenda and sent to the SAR email distribution list prior to the meeting and the following motion was made:***

***Motion to approve all SAR Mission Reimbursement requests as submitted and recommended above with funding authorized by State DES utilizing the appropriate fund source (Jurgonski). Second (DeCunzo). Approved unanimous.***

*Training Type: Rope Rescue Training*

*Description: Intensive 3 day to introduce Rapid Extrication Module (REMS) concepts and practices beyond the application of traditional vertical rescue training and tactics taught in Rope Operations and Technician courses. At completion of the workshop students should be aware of and able to articulate the unique mission demands of REMS and the options for various rescue systems and methodologies.
