#### **SAR Financial Update**

- > Funds Balance
  - See attached financial update
  - The SFY 2024 total appropriation is \$132,154, with just over \$110,000 remaining for the state fiscal year
  - It is possible for the state to request additional spending authority, but it is not a
    guarantee. The committee should plan to expend all of the current appropriation, but not
    count on additional authority at the end of the year.
  - Gilbertson reminded teams that mission reimbursement requests would be evaluated and voted on at each quarterly meeting throughout the year, but that training and equipment reimbursement requests would be evaluated and voted on at the last meeting of the state fiscal year, which will take place on June 11, 2024.
  - Tom Curtis inquired about a Lake County Equipment Reimbursement request. Gilbertson reported that all requests submitted via Survey123 have been recorded and according to the records, there is not a request from Lake County for equipment. Curtis and Gilbertson will work together to figure out if there is a glitch with the system.
- MSPOA Training Fund Balance

  - Expectation is that the team submits for reimbursement via DES once training is complete and that MSPOA is reimbursed

  - Chair Boxmeyer reminded subcommittee members that all spending requests are on a reimbursement basis and that teams should not count on the funding, especially for training and equipment requests because there is no guarantee that requests will be approved and/or that there will be enough money to fund all requests at 100%.
  - Secor informed the subcommittee members that all reimbursement requests come via the online Survey123 platform and are reviewed for accuracy and documentation and are corrected, if need be, prior to being placed on the agenda. All requests and appropriate documentation are housed in the online platform.

Reimbursement Purpose = Fuel (Boat and Air)

Resources: Jamie Chamberlin use of jet boat (Gallons of fuel), Craig Hostetler pilot (fuel),

**Narrative**: Renee Arcand reported missing on 6-30-23 to Dawson County Sheriff's Office. Believed to have drowned in Yellowstone River. Land, air, water patrols were initiated in earnest along with drones and canine units. Various ongoing searches have been conducted all summer and fall. We are now in a pause for our search efforts

**Resolution**: As of 9-1-23 still looking on river twice/week boat patrols; once/week air patrol. As of 10-8-23 Renee Arcand still missing and search efforts have been paused.

→ Roosevelt County SO SAR

August 26, 2023

Total = \$6,138.67

Reimbursement Purpose = Food, lodging

**Resources**: Below is a list of the Counties with number of people that was deployed. Rosebud County (1), Valley County Air (1), Fort Peck Tribes (2), Park County (2), Badlands Search and Rescue (4), Lewis & Clark County (7) & Lewis and Clark Helicopter (1), Stillwater County (3), Gallatin County (1).

**Narrative**: Locate missing adult male. **Resolution**: Located body-deceased.

#### Mission

→ Valley County SO SAR

August 12, 2023

Total = \$87.55

Reimbursement Purpose = Fuel (Boat and Air)

Resources: Lake Boat, SAR Volunteers, SAR Deputy

Narrative: On Saturday, August 12, 2023, At 18:08 hours Valley County Dispatch received a call from boaters on Fort Peck lake that were lost. This occurred during a storm that made navigation on the lake nearly impossible with wave size, wind, hail, rain. This couple had never been on the lake before and they did not have any navigation instruments to assist. They called 911 requesting help. We were able to determine their location with the 911 mapping system and SAR was activated by Sheriff Boyer. The SAFE boat was launched and proceeded to the last location where the boaters had been pushed by the wind and waves to the shoreline. The boat was beached and anchored. SAR arrived, at approximately 20:06, and the two adults were escorted back to the marina in the SAFE boat. Their watercraft was left on shore and would be retrieved the next day at their expense. They arrived back to the marina at 21:10. The mission was complete when the boat was refueled at 22:20 and returned to the barn.

**Resolution:** Members of SAR retrieved the lost boaters and transported them through the storm back to the Fort Peck Marina without incident. Deputy transported on land to their campsite. Lost boaters retrieved they water vessel the next day.

→ Cascade County SO -- CCMPSAR

November 27, 2023

Total = \$199.13

Reimbursement Purpose = Mileage

**Resources**: CCMPSAR (5), CCSO Deputies 17 and 34, Great Falls Fire Rescue (3), and Memorial

**Ambulance** 

**Narrative:** On November 27, 2023 at 1145 hrs, the Cascade County Sheriff's Office was summoned for mutual aid to the Kershaw, MT Grain Elevator for a male who passed away and fell inside a large grain bin on a catwalk and made it impossible for other employees to access him. CCMPSAR was requested and responded along with 2 CCSO Deputies, to assist.

Rescuers were able to descend to get the decedent out of the grain elevator.

**Resolution:** The Occurrence of this was that a grain elevator employee was atop of one of the extremely large grain bins when he fell inside the grain bin and onto a catwalk inside. The decedent fell against the catwalk door which did not allow anyone access to him. Hence, that is one of the reasons our CCMPSAR was called to assist with the high angle rescue to lift him out and off the grain elevator.

→ Butte Silver Bow County SO – 15-90 SAR

December 3, 2023 Total = \$1,331.05

Reimbursement Purpose = Mileage

Resources: 29 Units in 20 vehicles with 5 atv/utvs.

**Narrative:** After approximately 6 hours of searching the Camp Creek/Soap Gulch/Trapper Creek areas the family received a phone call that the 2 missing trappers has been picked up in the Gibbons Pass area, 80 miles from the area the Unit had been guaranteed they were trapping/hunting in.

**Resolution:** The 2 missing trappers were found in good condition in the Gibbons Pass area, 80 miles from the area the Unit had been guaranteed they were trapping/hunting in.

Motion: Approve all of the above SAR Mission Reimbursement Requests, for a total of \$9,157.90, with funding authorized by State DES (Hansen). Second (LaLiberty). Approved unanimous.

## > Training

#### > Equipment

See addendum for SFY24 Equipment Reimbursement Requests. Equipment reimbursement requests can be submitted throughout the year, but will not be evaluated and voted on until the final meeting of the state fiscal year.

#### **Open Comment/Public Comment**

- > Tom Curtis: Scope of Practice for Medical Response in SAR Teams. If teams are going to go with a licenses position, such as EMT, the licensure and training can be expensive and onerous. Lake County has developed an accepted scope of practice that details what medical procedures teams can and cannot perform. Need to ensure voluntary SAR members are not providing services outside their scope of practice. MT Department of Labor and Industry regulate emergency medicine scope of practice. Certain criteria for "emergency medical responder" which has licensure requirements as well as liability protections.
- > State of MT does establish certification levels for certain emergency medicine practitioners (EMR, EMT, paramedic) and people must perform duties ONLY within their scope of practice and within licensure.
- There is a way to deliver medical care through simple certifications that do not require a medical director on the team.

- > Put on old business for a full discussion (and perhaps presentation) for the April meeting. All SAR teams are not created the same nor do they have the same resources. Some teams have certified medical responders and others do not.
- Jurgonski: Madison County working on licensure for some SAR/EMT members who are responding to SAR calls.
- > Tom Curtis This is an important discussion for SAR teams. Lake County will have a document to guide medical procedures SAR team members are able to perform until they can be handed off to advanced medical care.
- ➤ Burleigh Curtis Ravalli County is using a non-transporting license from the state, which was not an overly difficult process and solved the issue for the team in Ravalli County.
- > JJ: What is the decision point for this subcommittee?
- ➤ Gilbertson: There really is not one. The purpose of the discussion is to ensure teams to learn from each other and share information. This subcommittee does not have the authority to establish any criteria or mandate any certain/specific level of care or licensure for SAR Teams.
- > Jon Trapp: Carbon County has a robust medical team. For new members they provide baseline medical training via a wilderness first responder class or a wilderness first aid class and the team members are required to bring back the knowledge to the team. It is not a licensure, but is based on a national standard. Also require basic first aid and CPR for all team members. Hold a wilderness first aid course once per year for SAR members.
